LICENSE AND CREDENTIAL INFORMATION

All participants (drivers, officials, crew, guests and VIPs) requiring HOT PIT ACCESS must complete the Annual Credential Application Form, and hold a valid SCCA Membership, to obtain an SCCA PRO / Radical Cup Credential or 'hard card'.

Annual Driver Application Form (\$215 + SCCA Membership)

Annual Crew Application Form (\$85 + SCCA Membership)

Single event credentials (\$50), which includes temporary SCCA membership, for international drivers, officials, crew and guests requiring single event HOT PIT ACCESS can be obtained at the track during registration hours.

Guests not requiring hot pit access may utilize guest credentials issued at the events, however quantities will be limited in accordance with the Event Promotor rules.

Please work through the check list.

- Are you a foreign driver? International FIA Licenses (including Canadian CASC) with International Competition Authorization letters will be accepted. However, you will still need to become a member of the SCCA.
- Already hold a valid SCCA Club Full Competition or SCCA PRO License, which won't expire before the final event (Nov 17, 2019)? Perfect, supply a copy of our license with your application and you will have your license upgraded to the Radical PRO license for the discounted rate of \$115.
- Already hold a valid SCCA membership, which won't expire before the final event (Nov 17, 2019)? Perfect, you will just need to pay the PRO fee.
- If you prefer, you can join or renew your SCCA membership online at www.scca.com, but note you must still complete the PRO application and forms.
- SCCA Annual Release and Waiver of Liability must be PRINTED AND SUBMITTED IN COLOR. There are alternatives to having these forms notarized– you can have them witnessed and signed by another SCCA member, or signed by an SCCA Registrar at your first event.
- All Minors (under 18) must also complete the [SCCA Minor Waiver Form](#).
- All drivers must also have a current Medical Form on file with the SCCA (New form required only for new SCCA drivers, those with an expired SCCA medical, or those applying for FIA license). Similar forms from NASA and FAA may be acceptable (IMSA / USAC not accepted). Medical must be dated within 6 months.
- Considering racing overseas? If you wish to apply for an FIA International License and International Competition Authorization letter at the same time as the SCCA PRO License, your Medical must be dated within 3 months, and you must also complete an [FIA License Application](#).
- An electronic head shot is required for your hard card (all photo formats accepted). If you already have a photo on file with SCCA, you can use that one.
- Submit a COLOR electronic copy of your complete application (scan or photos of each page ok) and head shot to Hanna Orme horne@sccapro.com .
- Pack with your racing gear, a COLOR copy of your documents to bring to your first event (especially if you still need your waivers witnessed or notarized).
